Whereas, a committee was constituted vide this office Order No.DIVK-E 2012 dated 31-05-2012 for examining the issue;

Whereas, the committee in its report has recommended that the seniority of Smt. Ayesha Banoo shall be maintained in Divisional Cadre Kashmir w. e. f. 26-10-2002 (from the date she was transferred to Divisional Commissioner, Kashmir's Office);

Whereas, tentative seniority list of Jr. Assistants of Divisional Cadre Kashmir as it stood on 30-04-2013 was issued vide this office endorsement No.DivCom/23-G/SLJA/Estt dated 29-06-2013;
