## Notice for inviting objections

Whereas, final seniority list of Girdawars of Kashmir Valley was issued vide this office Order No.749 DIVK-E-2014 dated 18-02-2014;

Whereas, while issuing the superannuation notice of Non-Gazetted officials of Divisional Cadre Kashmir, it has emerged from the records furnished by Deputy Commissioner, Anantnag that the date of birth of Shri Ghulam Mohammad Yatoo, Girdawar is 07-12-1961 whose name is figuring in the seniority list of Girdawars at S. Whereas Financial Commissioner (Revenue), J&K vide letter referred above has advised Divisional administration to incorporate the corrections in the final seniority list of Girdawars of Kashmir Valley which has already been prepared by the Financial Commissioner (Revenue)'s Office in the final combined seniority list of Girdawars of the State:

Before issuing revised seniority list of Girdawars of Kashmir Valley viz-a-viz change of residences inclusion of category certificate and date of births, objections are invited from all the interested persons. The objections should reach this office within 15days from the date of issuance of this notice. After the expiry of stipulated period, no objection shall be entertained.
