Whereas, in terms of Government Order No. 34-JK (DMRRR) of 2022 dated: 22-06-2022 issued by the department of Disaster Management, Relief, Rehabilitation & Reconstruction J&K under endorsement No. DMRRR-ADM/58/2022 dated: 22-06-2022, the appointing department is required to notify/ maintain separate seniority for employees appointed under Hon'ble PM Package which shall run parallel to the seniority of the regular employees in the appointing departments and shall take effect from the date of effect against these posts; and

Whereas, tentative seniority list of MTS of Divisional Cadre Kashmir appointed under PM Package was issued vide this office notification dated: 01-07-2022 under endorsement No. DivCom/Estt-267-Genl/MSTL/409-28 dated: 01-07-2022 for inviting objections from the interested persons; and

Whereas, one of the objections received was that the seniority be framed in accordance to the merit; and

Whereas on exploring the options of drafting the seniority on the basis of merit, it has been observed that many changes have accrued on account of inter-se-seniority among the official in consideration; and

Whereas, a final opportunity was given to all the stakeholders by way of issuing a revised tentative seniority vide this office Notification dated: 13-04-2023 issued under endorsement No. DivCom/267-Genl/MSTL/Estt/Sgr/306-321 dated: 13-04-2023 for inviting objections from the interested persons within 15 days from the date of issuance of the notification; and

Whereas, no objections have been received till date regarding the seniority list of MTS appointed under PM Package from any quarter.


Now therefore the updated seniority list of MTS of Divisional Cadre Kashmir appointed under PM Package as on 01-03-2023 is hereby issued forming Annexure "A" to this order.

In case of any official(s) feels aggrieved with the position assigned to him/her in the seniority list he/she may file a review petition, as per the relevant provisions of the Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rules 1956. The review petitions, if any, containing facts that have not been considered and have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issue of this order failing which his/her position in the seniority list shall be deemed final.

The seniority list shall, however, be further subject to final outcome of the pending court case(s), if any.

The DOB recorded/indicated against the official(s) in the seniority list shall not be taken as authenticate, and, shall be subject to further verification from the service book/matriculation certificate/ other relevant record as prescribed under norms.
