Subject: Promotion of Patwaries/Surveyors as Girdawar Qanoongos.

ORDER NO: 694 DIVK 2016

DATED : 07- 12 - 2016

Whereas; the Patwaries/Surveyors as per annexure "A" to this order were cleared for promotion as Girdawar Qanoongos by the Departmental Promotion Committee in its meeting held on 24/06/2016, however, during the process for issuance of formal orders it was felt necessary to review the decision in light of Hon'ble High Court Order dated 30/05/2016 passed in clubbed writ petition No.2275/15 CW SWP No.1762/2015 and 2235/2015 titled Javid Ahmad Shah and others V/S State and others, the verbatim of which is as under: -

- a. The official respondents are directed to undertake the exercise to find out as to which, amongst the selected/appointed candidates, qualified their Patwar Training Course Examination within the probation period and thereafter determine their seniority in accordance with the merit secured by them in the selection/merit list prepared by the Service Selection Board at the time of their selection. Those Patwaries, who qualified the Patwar Training Course Examination beyond the probation period shall rank junior to those Patwaries who qualified the said examination within the probation period though they ranked below them in the initial Selection List prepared by the Service Selection Board.
- b. After framing of fresh seniority list, in view of the aforesaid direction, the concerned official respondents shall amend the promotion orders, already made, and grant promotion to the Patwaries on the basis of the seniority list so framed. The concerned official respondents shall also, while amending/framing the seniority list, ensure that the Government order No.Rev(NG)-52 of 2015 dated 09th March, 2015 is complied with;
- c. The concerned official respondents to initiate and conclude the aforesaid exercise within eight weeks from the date copy of this order is received by them.
- d. Till the aforesaid exercise is completed, the promotion orders made, shall remain undisturbed. Interim directions in all these petitions, shall stand vacated."

Writ petitions are disposed of along with CMPs

Whereas, in compliance to the directions of the Hon'ble High Court the seniority was reviewed and reframed by the Deputy Commissioners and accordingly their cases were again placed before the Departmental Promotion Committee on 31/10/2016 which after due consideration of the Hon'ble Court Orders recommended to accord promotional benefits in favour of these officials notionally w. e. f. 06/10/2015 and regularly w. e. f. 24/06/2016.

Now, therefore, in view of the above sanction is hereby accorded for promotion of Patwaries/Surveyors as per annexure "A" to this order as Girdawar Qanoongos in the pay band of 9300-34800 with Grade Pay of Rs.4200/- notionally w. e. f. 06/10/2015 and regularly w. e. f. 24/06/2016. The promotees shall join in the office of Divisional Commissioner, Kashmir for further posting.

This order shall be without prejudice to the outcome of court case/cases, if any, pending before any competent Court.




