The seniority list shall, however, be subject to final outcome of the pending court case(s), if any.

The DOB recorded/indicated against the official(s) in the seniority list shall not be taken as authentic, and, shall be subject to further verification from the service book/matriculation certificate/ other relevant record as prescribed under norms.


