Subject: Final Seniority list of Girdawars of Kashmir Valley and notification thereof.

Notification

Whereas, this office issued a final seniority list of Girdawars vide Order No.749 DIVK-E-2014 dated 18-02-2014;

Whereas, this office has received an application from Shri Nazir Ahmad Rather which reveals that he was promoted as Girdawar vide this office Order No.738/DIVK-E-2010 dated 23-01-2010 and has been posted in the office of Settlement Officer, Kashmir as Girdawar;

Whereas, Shri Nazir Ahmad Rather has further stated that in the seniority list of Girdawars submitted by this office to the Financial Commissioner (Revenue), J&K he has been shown as "I/C Girdawar" instead of "Girdawar".

Whereas, Shri Nazir Ahmad Rather has requested that necessary correction may kindly be made in the seniority list of Girdawars in this regard on the grounds that he has been cleared by the Departmental Promotion Committee on 30-12-2009 and subsequently has been promoted as Girdawar vide this office Order No. 738/DIVK-E-2010 dated 23-01-2010;

Whereas, from the perusal of the records available in this office, the claim of Shri Nazir Ahmad Rather has been found genuine that the mistake was purely a clerical one;

Whereas, on the perusal of records reveal that the correction requested for will not affect the seniority of any other Girdawar as Shri Nazir Ahmad Rather will remain continuously at S. No.248 in the seniority list of Girdawars where he already exists.

Now, therefore, before issuing the requisite corrigendum in this regard, if any interested persons has objection to the above, he may file the objection in the office of Divisional Commissioner, Kashmir within a period of one week. Thereafter no such application will be entertained.
