Whereas, Deputy Commissioner, Budgam vide letter No: DCB/SQ/21/ F=97/LA/178 dated 22.05.2021, No. DCB/SQ/2022/F=97/LA/414 dated 21.05.2022 and No. DCB/SQ/2023-24/LA/F=97/4606 dated 02.01.2024 has reported that the alienor(s) intend to alienate land measuring 04 kanals 01 marla falling under Khasra No. 1232min (03K-19M) and 1234-min (02M) situated at village Nagam, Tehsil Chadoora District Budgam; and

Whereas, Deputy Commissioner, Budgam in terms of rule 3(b) of JRF Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No. DCB/ SQ/21/F=97/LA/178 dated 22.05.2021; and

Whereas, to rule out the possibility of distress sale the aliencr(s) was/were heard on video call who authenticated the veracity of the documents executed by him/her/ them and also intimated that the sale has not been made in distress/duicss and consented to the grant of alienation permission in favour of the alienee(s).

- b) That the value of the property (land)under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under agriculture category of land of estate Nagam, Tehsil Chadoora, District Budgam as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act. 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Budgam (Custodian of the Migrant !mmovable P:cperty) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
