Omkar Nath Raina R's/o Kurigam, Tehsil Qazigund, District Anantnag A/P Migrants (1-2) 148/4, Pamposh Colony, Janipur, Jammu and (3) Lane No. 3 Gurha Keran, Barnai Bantalab Jammu for permission to alienate migrant immovable property in accordance with the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997.

Whereas, Deputy Commissioner, Anantnag's letter No: DCA/MLA/(1265)/19-20/626 dated 16.11.2019, No: DCA/MLA/(1265)/19-20/780 dated 27.12.2019 and No: DCA/MLA/(1265)/22-23/1508 dated 07.02.2023 has reported that the alienor(s) intend to alienate land measuring 01 kanal 10 marlas covered under Survey No. 1101/412-min situated in estate Kurigam, Tehsil Qazigund, District Anantnag; and

Whereas, Deputy Commissioner, Anantnag after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the land measuring 01 kanal 10 marlas covered under Survey No. 1101/412-min situated in estate Kurigam, Tehsil Qazigund, District Anantnag vide his above referred letter, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

Whereas, the Deputy Commissioner Anantnag in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement DCA/MLA/(1265)/19-20/626 dated 16.11.2019, No: DCA/MLA/(1265)/19-20/780 dated 27.12.2019; and


Whereas, to rule out the possibility of distress sale, the alienor(s) were heard on video call who authenticated the veracity of the documents executed by them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation: land measuring 01 kanal 10 marlas covered under Survey No. 1101/412-min situated in estate Kurigam, Tehsil Qazigund, District Anantnag BY S/Sh. (1)

Poshkar Nath Raina, (2) Pran Nath Raina S/o Shri Lt. Radha Krishan Raina and (3) Veer Ji Raina S/o Lt. Sh. Omkar Nath Raina R's/o Kurigam, Tehsil Qazigund, District Anantnag A/P Migrants (1-2) 148/4, Pamposh Colony, Janipur, Jammu and (3) Lane No. 3, Gurha Keran, Barnal Bantalab, Jammu IN FAVOUR OF Mst. Mahjabeena W/o Nazir Ahmad Baba R/o Kurigam, Tehsil Qazigund, District Anantnag, subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/registering of Sale Deed applicable under **residential category** of land of **estate Kurigam**, Tehsil Qazigund, District Anantnag as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Anantnag (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
