Whereas, Deputy Commissioner, Srinagar's letter No: DCS/SQ/MLA/844/3077/MR dated 30.05.2019 has reported that the alienor(s) intend to alienate land measuring 1329 Sfts along with house falling under Khasra No. 600-min situated in estate S. R. Gunj, Tehsil Khanyar, District Srinagar;

- That after completion of all registration formalities, the District d) Magistrate Srinagar (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
