No. 99, Lane No. 2, Block-A, Roopnagar, Jammu for permission to alienate migrant immovable property in accordance with the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997.

Whereas, Deputy Commissioner, Shopian's letter No: DCS/SQ/22-23/535 dated 03.06.2022 and No. DCS/SQ/22-23/938-39 dated 27.07.2022 has reported that the alienor(s) intend to alienate **land measuring 04 kanals falling under Survey No. 381/217-min situated in estate Kharwara, Tehsil Hermain, District Shopian,** and

Whereas, Deputy Commissioner, Shopian after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the **land measuring 04 kanals falling under Survey No. 381/217-min situated in estate Kharwara, Tehsil Hermain, District Shopian** vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

Whereas, Deputy Commissioner, Shopian in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Rules, 1997 has also issued "**No Objection Certificate**" under endorsement No. DCS /SQ/22-23/535 dated 03.06.2022 and No. DCS/SQ/22-23/938-39 dated 27.07.2022. and


Whereas, to rule out the possibility of distress sale, the alienor(s) was heard on video call who authenticated the veracity of the documents executed by him/her/ them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore, in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation of **land measuring 04 kanals falling under Survey No. 381/217-min situated in estate Kharwara, Tehsil Hermain, District Shopian** BY (1) Maharaj Krishen and (2) Sudesh Kumar Pandit S's/o of Late Sarwanand Pandit (Adopted son of Late Dina

Nath Pandit) R's/o Kharwara Tehsil Hermain, District Shopian A/P H. No. 99, Lane No. 2, Block-A, Roopnagar, Jammu IN FAVOUR OF Abdul Hamid Wagay S/o Abdul Gani Wagay R/o Kharwara, Shopian, subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property under proposed alienation shall be calculated as per the stamp rate for the calendar year 2023 of estate Kharwara, Tehsil Hermain, District Shopian as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011 for the Calendar year 2023.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Shopian (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.

- 2) AS THE MARKET VALUE OF IMMOVABLE PROPERTY IS FIXED ANNUALLY ON CALENDAR YEAR BASIS, THE VALIDITY OF THE PERMISSION SHALL CEASE TO EXIST AT THE END OF THE CURRENT CALENDAR YEAR I.E. 31ST OF DECEMBER, 2023.
