- a) That the applicant(s) are rightful owners/occupants of the proper proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsilda, concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under residential execution/ registering of sale Deed applicable under residential execution/ registering of sale Deed applicable under Chowk, category of land of estate Zawoora, Tehsil Pantha Chowk, District Srinagar as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- C) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate Srinagar (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
