Whereas, Deputy Commissioner, Shopian after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of land measuring 01 kanal 02 marlas covered under Survey No. 964-min situated in estate Wachi, Tehsil Zainapora, District Shopian vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

- a) That the applicant(s) is/are rightful owners/occupants property proposed to be alienated and is free from encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- That the value of the property under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under irrigated agriculture category of land of estate Wachi, Tehsil Zainapora. District Shopian approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- Property (Preservation, Protection & Restraint on Distress Sales)
  Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- That after completion of all registration formalities, the District Magistrate, Shopian (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alience(s) thereof through prescribed procedure.
