Whereas, Deputy Commissioner, Anantnag's letter No: DCA/MLA/(1247)/20-21/905 dated 18.01.2021 and DCA/MLA/(1247)/20-21/173 dated 15.06.2021 has reported that the alienor(s) intend to alienate land measuring 15 kanals 13 marlas falling under Survey Nos. 122 (03K-14M), 311 (11K-11M) and 311/1 (08M) situated in estate Trail, Tehsil Srigufwara, District Anantnag; and

Whereas, Deputy Commissioner, Anantnag after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the land measuring 15 kanals 13 marlas falling under Survey Nos. 122 (03K-14M), 311 (11K-11M) and 311/1 (08M) situated in estate Trail, Tehsil Srigufwara, District Anantnag vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

Whereas, the Deputy Commissioner Anantnag in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No. DCA/MLA/(1247)/20-21-905 dated 18.01.2021 and DCA/MLA/(1247)/20-21/173 dated 15.06.2021; and


Whereas, to rule out the possibility of distress sale, the alienor(s) were heard on video call who authenticated the veracity of the documents executed by them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation land measuring 15 kanals 13 marlas falling under Survey Nos. 122 (03K-14M), 311

(11K-11M) and 311/1 (08M) situated in estate Trail, Tehsil Srigufwara, District Anantnag BY (1) Tota Ram S/o Shiv Ram (2) Smt. Badri Devi (alias Somavati) W/o Late Dwarika Nath Bhat (3) Smt. Krishna Devi alias Raj Karni (wife), (4) Triloki Nath Bhat, (5) Ashok Kumar Bhat and (6) Sanjay Kumar Bhat S's/o Late Sh. Radha Krishan Bhat R's/o Trail, Pahalgam A/P (1) Qtr. No. 14., L. No. 7, Block No. 31, Jagti Nagrota, Jammu, (2) H. No. 24, Lane No. 5, Saraswati Vihar, Bohri, Jammu, (3) Qtr. No. 13., L. No. 9, Block No. 49, Jagti Nagrota, Jammu, (4) Qtr. No. 22., L. No. 9, Block No. 49, Jagti Nagrota, Jammu, (5) Qtr. No. 23., L. No. 9, Block No. 49, Jagti Nagrota, Jammu and (6) Qtr. No. 14., L. No. 9, Block No. 49, Jagti Nagrota, Jammu (in Person) IN FAVOUR OF (1) Mohammad Abbas Wani and (2) Shafiq Ahmad Wani S's/o Ghulam Nabi Wani R's/o Sarnal Balla, Tehsil Srigufwara, District Anantnag in equal shares, subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property under proposed alienation shall be calculated as per the stamp rate for the **calendar year 2023** of **estate Trail**, Tehsil Srigufwara, District Anantnag as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Anantnag (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.

- 2) AS THE MARKET VALUE OF IMMOVABLE PROPERTY IS FIXED ANNUALLY ON CALENDAR YEAR BASIS, THE VALIDITY OF THE PERMISSION SHALL CEASE TO EXIST AT THE END OF THE CURRENT CALENDAR YEAR I.E. 31ST OF DECEMBER, 2023.
