Whereas, Deputy Commissioner, Kupwara vide letter No: DCK/SQ/ Alienation/23/69 dated 04.10.2023 and No. DCK/M.Cell/Alienation/(7444964)/24/240-41 dated 30.04.2024 has reported that the alienor(s) intend to alienate land measuring 17 kanals 01 marla covered under Survey Nos. 746 (03K-03M), 747 (03K-06M), 748 (02K-11M), 750 (01K-03M), 751 (07M), 752 (01K-04M), 753 (09M), 754 (01K-07M), 755 (03-01M), 749 (10M) situated in estate Trehgam, Tehsil Trehgam, District

Whereas, Deputy Commissioner, Kupwara, after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines Kupwara; and in vogue has verified title,/and possession of the land measuring 17 kanals 01 marla covered under Survey Nos. 746 (03K-03M), 747 (03K-06M), 748 (02K-11M), 750 (01K-03M), 751 (07M), 752 (01K-04M), 753 (09M), 754 (01K-07M), 755 (03-01M), 749 (10M) situated in estate Trehgam, Tehsil Trehgam, District Kupwara vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997;

Whereas, to rule out the possibility of distress sale, the alienors were heard on video call who authenticated the veracity of the documents executed by them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under unirrigated horticulture category of land of estate Trehgam, Tehsil Trehgam, District Kupwara as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Kupwara (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
