Whereas, Deputy Commissioner, Kupwara vide letter No: DCK/SQ/Alienation/18/484 dated 11.07.2018, No. DCK/SQ/Alienation/18/963 dated 19.10.2018 and No. DCK/M.Cell/Alienation/(7390696)/24/216-17 dated 26.03.2024 has reported that the alienor(s) intend to alienate land measuring 02 kanals 02 marlas falling under Survey Nos. 860 (01K-02M) and 862 (01K) situated in estate Gund Gushi, Tehsil & District Kupwara; and

Whereas, Deputy Commissioner, Kupwara, after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title,/and possession of the land measuring 02 kanals 02 marlas falling under Survey Nos. 860 (01K-02M) and 862 (01K) situated in estate Gund Gushi, Tehsil & District Kupwara vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997;

Whereas, Deputy Commissioner Kupwara in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No: DCK/SQ/ Alienation/18/484 dated 11.07.2018; and


Whereas, to rule out the possibility of distress sale, the alienor(s) was/were heard on video call who authenticated the veracity of the documents executed by them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act. 1997, sanction is hereby accorded to the alienation land measuring 02 kanals 02 marlas falling under Survey Nos. 860 (01K-02M) and

862 (01K) situated in estate Gund Gushi, Tehsil & District Kupwara BY S/Sh. (1) Radha Krishen Raina, (2) Giridhari Lal Raina S's/o Sh. Sansar Chand, (3) Tej Krishan Raina, (4) Manohar Lal Raina, (5) Dileep Kumar Raina (sons), (6) Smt. Usha Pandita (daughter), (7) Smt. Gopi Shori Raina W/o Late Sh. Soom Nath Raina, (8) Ravinder Kumar Raina, (9) Sanjive Raina, (10) Shuban Krishan Raina (sons) and (11) Smt. Sham Rani W/o Late Sh. Prithvi Nath Raina R's/o Gund Gushi, Tehsil & District Kupwara A/P Migrants Muthi, Jammu IN FAVOUR OF (1) Rashid Hussain Mareed S/o Ashiq Hussain Mareed R/o Gosse, Tehsil & District Kupwara and (2) Saraj Din S/o Noor Din R/o Gundi Gujran, Tehsil Karnah District Kupwara, subject to the following conditions: -

- a) That the applicant(s) are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under un-irrigated agriculture (01K-02) and horticulture (01K) categories of land of estate Gund Gushi, Tehsil & District Kupwara as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Kupwara (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
