Whereas, Deputy Commissioner, Kupwara vide letter No: DCK/SQ/Alienation/20/725 dated 16.01.2021, No: DCK/SQ/Alienation/22/1903 dated 25.07.2022 and No. DCK/SQ/Alienation/ (7302197)/24/230 dated 30.03.2024 has reported that the alienor(s) intend to alienate land measuring 18.5 marlas falling under Survey No. 631 (04M-2.15 Sirsai) and 634 (14M-2.35 Sirsai) situated in estate Karihama, Tehsil & District Kupwara; and

Whereas, Deputy Commissioner, Kupwara, after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title,/and possession of the land measuring 18.5 marlas falling under Survey No. 631 (04M-2.15 Sirsai) and 634 (14M-2.35 Sirsai) situated in estate Karihama, Tehsil & District Kupwara vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997;

Whereas, Deputy Commissioner Kupwara in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales). Rules, 1997 has also issued "No Objection Certificate" under endorsement No. DCK/SQ/ Alienation/20/725 dated 16.01.2021; and

Whereas, to rule out the possibility of distress sale, the alienor(s) appeared in person who authenticated the veracity of the documents executed by him/ them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act. 1997, sanction is hereby accorded to the alienation of land measuring 18.5 marlas falling under Survey No. 631 (04M-2.15 Sirsai) and 634 (14M-2.35 Sirsai) situated in estate Karihama, Tehsil & District Kupwara BY S/Sh. (1) Mohan Lal Pandita and (2) Sanjay Kumar Pandita S's/o Late Ram Chand

Pandita R's/o village Gushi Karihama, Tehsil & District Kupwara A/P Migrants at Migrant Camp, Purkhoo, Domana, Jammu IN FAVOUR OF Mushtaq Ahmad Malik S/o Ghulam Ahmad Malik R/o Baghat Mohalla, Gushi Karihama, Tehsil & District Kupwara, subject to the following conditions: -

- a) That the applicant(s) are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate prevailing at the time of execution/ registering of Sale Deed applicable under residential category (04M-2.15 Sirsai) and unirrigated agriculture category (14M-2.35 Sirsai) of land of estate Karihama, Tehsil & District Kupwara as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Kupwara (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
