- iii) That the permit will remain in force for a period of sixty (60) days only from the date of dispatch of this permit.
- iv) That before felling down of walnut trees, rightful owner(s) must be verified properly by the Tehsildar concerned.
- iv) That no contravention of any act/rule takes place under the garb of this permit.
- v) That the permit is issued on the condition that the Principal/ Director, Tyndale-Biscoe & Mallinson School, Sheikh Bagh, Tehsil South District Srinagar will ensure plantation of at least (10) ten new walnut tree saplings in the safer zone of school vicinity during incoming sowing/plantation season.
